A pre-proposal conference for this project is scheduled for **11:00 AM Moscow time on July 25, 2019** at Bolshoy Devyatinskiy pereulok, 8, Moscow, Russian Federation. All interested offerors are invited to attend and must request access at least 24 hours in advance.

Proposals are due **on or before 4:00PM Moscow time on August 7, 2019** and must be submitted electronically to MoscowProcurement@state.gov. All quotes are to be addressed to the Contracting Officer and marked "Quotation 19RS5019Q0026 Enclosed." **The email size shall not exceed 20MB.**

The offerors should notify the contact listed in Block 7.A of Standard Form 1449 on page 3 of this solicitation to confirm receipt of the offer.

The U.S. Government intends to award a contract/purchase order to the responsible company submitting an acceptable quotation at the lowest price. We intend to award a contract/purchase order based on initial quotations, without holding discussions, although we may hold discussions with companies in the competitive range if there is a need to do so.

1. PERFORMANCE WORK STATEMENT

The Contractor shall provide professional passenger transportation and driver dispatch services for the United States Embassy in Moscow, Russia. The prices listed below shall include all labor, materials, insurance (see FAR 52.228-4 and 52.228-5), overhead, and profit. The Government will pay the Contractor a fixed price per month for Standard Services that have been satisfactorily performed. The Government will also pay the Contractor a fixed per unit price for Temporary Additional Services ordered by the Government for satisfactorily completed work.

2. TYPE OF CONTRACT

This is a fixed price contract with indefinite delivery/indefinite quantity for temporary additional services.

3. TYPES OF SERVICES

Standard Services. The Contractor shall provide standard professional passenger transportation and driver dispatch services as specified in Section 7.

Temporary Additional Services.

The Contractor shall provide Temporary Additional Services when requested by the Contracting Officer through a written order. Temporary Additional Services delivered shall be in addition to the Standard Services, and shall be priced at the unit price shown below. The tasks to be accomplished shall be additional quantities of the same tasks described in Section 7.

Because Temporary/Additional Services are based on indefinite delivery/indefinite quantity the minimum and maximum amounts are defined below:

Minimum: The Government shall place orders totaling a minimum of 50 hours. This reflects the contract minimum for the base year for temporary/additional services.

Maximum: The amount of all orders shall not exceed 1200 hours. This reflects the contract maximum for the base year for temporary/additional services.

The hourly rates for Temporary Additional Services, as defined in Section 7, are fully loaded rates, including:

- All direct and indirect labor costs (including any premiums relating to overtime, holidays or night shifts, etc.);

- All overhead and indirect costs, including general and administrative expenses (G&A); and Profit.

4. PRICING

- A. The Government will pay the Contractor a fixed price per month for Standard Services that have been satisfactorily performed. The Government will also pay the Contractor a fixed per unit price for Temporary Additional Services ordered by the Government for satisfactorily completed work. Payments shall be limited to actual services performed. No claim for any additional compensation shall be considered, unless it has been authorized by the Government in writing in advance. The Government shall not be responsible for any work performed which is not specifically provided for under the terms of this contract or authorized by the Government in writing in advance.
- B. OFFERS AND PAYMENT IN US DOLLARS – U. S. firms are eligible to be paid in U.S. Dollars. U.S. Firms desiring to be paid in U.S. dollars should submit their offers in U.S. dollars. A U.S. firm is defined as a company which operates as a corporation incorporated under the laws of a state within the United States.
- C. FOREIGN FIRMS – Any firm, which is not a U.S. firm, is a Foreign Firm. Foreign Firms are allowed to submit their quotes in U.S. Dollars. If a Foreign firm quoted its prices in local currency, the Government shall make payment in local currency. If a Foreign Firm quoted its prices in U.S. Dollars and did not possess a license to receive payments in U.S. Dollars, the Government shall make payments in local currency (Russian Rubles) in accordance with the Central Bank of Russia official exchange rate on the day of invoice issuance.
- D. VALUE ADDED TAX. Value Added Tax (VAT) is not included in the CLIN rates. Instead, it will be priced as a separate Line Item in the contract and on Invoices. Local law dictates the portion of the contract price that is subject to VAT; this percentage is multiplied only against that portion. It is reflected for each performance period. The portions of the solicitation subject to VAT are:
- E. The Contractor's rate shall also include all expenses and fees, such as medical examinations and lab tests, associated with the drivers receiving a driver's medical certificate required for each driver performing the services under this contract.

5. ADDITIONAL ALLOWABLE EXPENSES

Additional allowable expenses include toll fees, paid parking fees, airport and residential complexes parking/entrance fees associated with accessing the customer pick up, waiting, and drop off areas and incurred by the Contractor while transporting passengers on official business of the Embassy. The Contractor may claim reimbursement for these fees as a separate line item on the invoice. All additional allowable expenses shall be billed to the Embassy at cost with all receipts supporting the claim attached to the Contractor's invoice. All additional allowable expenses may be reimbursed back to the Contractor with COR approval only.

6. CONTRACT TERM

The term of this contract is from the start date in the Notice to Proceed and continuing for 12 months. The initial term includes any transition period authorized under the contract.

After contract award and submission of acceptable insurance certificates, the Contracting Officer shall issue a Notice to Proceed. The Notice to Proceed will establish a date (a minimum of ten (10) days from start date listed in Notice to Proceed unless the Contractor agrees to an earlier date) on which performance shall start.

7. WORK REQUIREMENTS

A. GENERAL

The Contractor shall provide professional passenger transportation and driver dispatch services for the US Embassy in Moscow. The Contractor shall furnish all managerial, administrative, and direct labor personnel that are necessary to accomplish the work in this contract. Contractor employees shall be on site only for contractual duties and not for other business purposes.

B. TYPES OF SERVICES TO BE PROVIDED AND CONTRACTOR OBLIGATIONS

B.1 The Contractor shall provide local passenger transportation and driver dispatch services (without vehicles) to US Embassy Moscow. All vehicles required for performance of services under this contract shall be provided by the Embassy (see Section 8 for the list of Government Furnished Property).

B.2 The Contractor shall designate a motor pool dispatcher who will receive, log and process the Embassy requests for passenger transportation services and coordinate the driver motor pool schedules with the COR. The dispatcher shall be the main Point of Contact between the drivers and the COR.

B.3 Assisting Passengers: The drivers shall provide assistance for passengers who may need minimal assistance getting in and out of a vehicle and assist with any luggage.

B.4 The Contractor shall provide qualified drivers for performance of services under this contract. Drivers employed to perform services shall be experienced and competent in the performance of such services, shall possess the appropriate licenses, and shall be fit for duty. All drivers must meet the minimum qualifications listed in Attachment 1.

B.5 The Contractor shall prepare general instructions for the work force. The Contractor shall provide drafts to the Contracting Officer's Representative (COR) for review within ten days after contract award. The Contracting Officer's Representative must approve these general instructions before issuance.

B.6 The Contractor shall enforce and implement a Safe Driver Program that covers:

- a) Involvement in planning, execution, and oversight of safety and risk management.
- b) Maintenance of all required training and certifications.
- c) Detailed planning and preparation to ensure safe and on-time performance.
- d) Continuous risk management to identify and eliminate or control hazards and ensure safe operations and protection of all personnel and assets.

- e) Applicable driver license or certificates for region, state, nation where operation will take place.
- f) No drugs or alcohol at any time before or during transportation of US Embassy personnel or guests.
- g) Prioritize safety over schedule and maintain safe speed.
- h) Good overall driver knowledge of routes planned to be taken and avoid areas containing environmental, industrial or other types of hazards.
- i) Maintenance of current transportation and equipment operation checklists.
- j) No use of hand-held communication devices while driving.
- k) For vehicles that come equipped with seatbelts, passengers will be requested to use their seatbelts in line with Executive Order 13043, "Increasing Seatbelt Use in the United States," which mandates seatbelt use by Federal Government employees on Government business when a vehicle is in motion.
- l) If an accident occurs in a Government vehicle, driver(s) will take steps to prevent another accident at the scene, exchange drivers' information, and get witnesses' information. Local authorities will be notified and medical assistance will be summoned if there are injuries. –
- m) Driver(s) will notify their supervisor as soon as possible and get a copy of the accident report. The Contractor is required to notify the COR of any accidents while operating a Government-owned vehicle, irrespective of severity.

8. GOVERNMENT FURNISHED MATERIALS AND PROPERTY

8.1 The Embassy shall provide all vehicles required for performance of services under this contract.

8.2 The Embassy shall provide all running expenses (i.e., fuel, oil, car washes, parking fees etc.), and including all servicing and maintenance of vehicles, insurance and fees of such vehicles that are necessary to accomplish all work required by this contract.

8.3 The Embassy shall provide two-way communication equipment (such as radios, cellular phones, and/or pagers) which shall be available for use by the driver at all times during the shift.

8.4 All materials, tools, and equipment not listed in Paragraphs 8.1-8.3 are the responsibility of the Contractor.

9. MANAGEMENT AND SUPERVISION

9.1 The Contractor shall designate a representative who shall be responsible for on-site supervision of the Contractor's workforce at all times. This supervisor shall be the focal point for the Contractor and shall be the point of contact with U.S. Government personnel. The supervisor shall have sufficient English language skill to be able to communicate with members of the U.S. Government staff and will be available at all times during the contract performance hours. The Contractor shall provide the Contracting Officer with names and

telephone numbers of supervisory personnel assigned to handle contract performance issues within 5 (five) calendar days after contract award.

9.2 The Contractor shall maintain schedules. The schedules shall take into consideration the hours that the staff can effectively perform their services without placing a burden on the security personnel of the Post. For those items other than routine daily services, the Contractor shall provide the COR with a detailed plan as to the personnel to be used and the timeframe to perform the service.

9.3 The Contractor shall be responsible for quality control. The Contractor shall perform inspection visits to the work site on a regular basis. The Contractor shall coordinate these visits with the COR. These visits shall be surprise inspections to those working on the contract.

10. SCHEDULES AND WORKING HOURS

10.1 The Contractor shall provide standard services during the hours of 6:00AM and 10:00PM Moscow time. Standard working hours are defined as any 9 (nine) consecutive hours worked by the driver (8 (eight) actual hours worked with a one-hour lunch break) between the hours of 6:00AM and 10:00PM Moscow time. All schedules are to be coordinated with the section/agency and the COR.

10.2 When the Government has accepted any time schedule, this acceptance shall be binding to the Contractor. The completion date is fixed and may be extended only by a written contract modification contract modification signed by the Contracting Officer. Acceptance or approval of any schedule or revision by the Government shall not:

- (1) Extend the completion date or obligate the Government to do so;
- (2) Constitute acceptance or approval of any delay, or
- (3) Excuse or relieve the Contractor of its obligation to maintain the progress of the work and achieve final completion by the established completion date.

10.3 The Contractor may sometimes be required to work outside of the business hours listed in Paragraph 9.1 or exceed a total of 8 actual hours worked during the business hours listed in Paragraph 9.1, in which case Temporary Additional Service rates shall apply.

10.4 Working hours of the contractor personnel shall not exceed the safe vehicle operation limit of 10 (ten) consecutive hours.

10.5 In the event that an employee of the Contractor is unavailable to provide services to the Embassy due to illness, the Embassy will continue to pay for services as normal for up to 3 days (24 hours) worth of services. Afterwards, the Contractor shall adjust the subsequent invoice to reflect a reduction in charges for any period where services are not provided. The Embassy may request a replacement driver for the duration of the absence of the regularly assigned driver.

11. LAWS AND REGULATIONS

Without additional expense to the Government, the Contractor shall comply with all laws, codes, ordinances, and regulations required to perform this work. In the event of a conflict among the contract and requirements of local law, the Contractor shall promptly advise the Contracting Officer of the conflict and of the Contractor's proposed course of action for resolution by the Contracting Officer.

The Contractor shall comply with all local labor laws, regulations, customs and practices pertaining to labor, safety, and similar matters, to the extent that such compliance is not inconsistent with the requirements of this contract.

12. TRANSITION PLAN

Within 5 (five) days after contract award, the Contracting Officer may request that the Contractor develop a plan for preparing the Contractor to assume all responsibilities for driver services. The plan shall establish the projected period for completion of all clearances of Contractor personnel, and the projected start date for performance of all services required under this contract. The plan shall assign priority to the selection of all supervisors to be used under the contract.

14. PERSONNEL

14.1 General. The Contractor shall maintain discipline at the site and shall take all reasonable precautions to prevent any unlawful, riotous or disorderly conduct by Contractor employees at the site. The Contractor shall preserve peace and protect persons and property on site. The Government reserves the right to direct the Contractor to remove an employee from the worksite for failure to comply with the standards of conduct. The

Contractor shall immediately replace such an employee to maintain continuity of services at no additional costs to the Government.

14.2 Standard of Conduct.

(a) Neglect of duties shall not be condoned. The Contractor shall enforce no sleeping while on duty, unreasonable delays or failures to carry out assigned tasks, conducting personal affairs during duty hours and refusing to render assistance or cooperate in upholding the integrity of the worksite security.

(b) Disorderly conduct, use of abusive or offensive language, quarreling, intimidation by words, actions, or fighting shall not be condoned. Also included is participation in disruptive activities, which interfere with normal and efficient Government operations.

(c) Intoxicants and Narcotics. The Contractor shall prohibit its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or substances that produce similar effects.

(d) Criminal Actions. Contractor employees may be subject to criminal actions as allowed by law in certain circumstances. These include but are not limited to the following actions:

- falsification or unlawful concealment, removal, mutilation, or destruction of any official documents or records or concealment of material facts by willful omission from official documents or records;
- unauthorized use of Government property, theft, vandalism, or immoral conduct;
- unethical or improper use of official authority or credentials;
- security violations; or,
- organizing or participating in gambling in any form

14.3 Notice to the Government of Labor Disputes

The Contractor shall inform the COR of any actual or potential labor dispute that is delaying or threatening to delay the timely performance of this contract.

14.4 Personnel Security

(a) After award of the contract, the Contractor shall within 5 calendar days provide the following list of data on each employee who will be working under the contract. The Contractor shall include a list of workers and supervisors assigned to this project. The Government will run background checks on these individuals. It is anticipated that security checks will take up to 30 days to perform. For each individual the list shall include:

- Full Name
- Place and Date of Birth
- Current Address
- Copy of the passport

- (b) The Government shall issue identity cards to Contractor personnel, after they are approved. Contractor personnel shall display identity card(s) on the uniform at all times while providing services under this contract. These identity cards are the property of the US Government. The Contractor is responsible for their return at the end of the contract, when an employee leaves Contractor service, or at the request of the Government. The Government reserves the right to deny access to U.S.-owned and U.S.-operated facilities to any individual.

15. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

15.1 SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

15.2 STANDARD. The performance standard is that the Government receives no more than three (3) complaints per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.

15.3 PROCEDURES.

- (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
- (b) The COR will complete appropriate documentation to record the complaint.

- (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
- (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
- (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
- (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

16.0 INSURANCE

16.1 Amount of Insurance. The Contractor is required to provide whatever insurance is legally necessary. The Contractor shall, at its own expense, provide and maintain during the entire performance period the following insurance amounts:

16.3 The types and amounts of insurance are the minimums required. The Contractor shall obtain any other types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.

16.4 For those Contractor employees assigned to this contract who are either United States citizens or direct hire in the United States or its possessions, the Contractor shall provide workers' compensation insurance in accordance with FAR 52.228-3.

16.5 The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to:

- a) any property of the Contractor,
- b) its officers,
- c) agents,
- d) servants,
- e) employees, or
- f) any other person

arising from an incident to the Contractor's performance of this contract. The Contractor shall hold harmless and indemnify the Government from any and all claims arising, except in the instance of gross negligence on the part of the Government.

16.6 The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

16.7 Government as Additional Insured. The general liability policy required of the Contractor shall name "the United States of America, acting by and through the Department of State", as an additional insured with respect to operations performed under this contract.

16.8 Time for Submission of Evidence of Insurance. The Contractor shall provide evidence of the insurance required under this contract within five (5) calendar days after contract award. The Government may rescind or terminate the contract if the Contractor fails to timely submit insurance certificates identified above.

(b) **TECHNICAL ACCEPTABILITY.** Technical acceptability will include a review of past performance and experience as defined in Section 3, along with any technical information provided by the offeror with its proposal/quotation.

(c) **PRICE EVALUATION.** The lowest price will be determined by multiplying the offered prices times the estimated quantities in "Prices - Continuation of SF-1449, block 23", and arriving at a grand total, including all options. The Government reserves the right to reject proposals that are unreasonably low or high in price.

(d) **RESPONSIBILITY DETERMINATION.** The Government will determine contractor responsibility by analyzing whether the apparent successful offeror complies with the requirements of FAR 9.1, including:

- Adequate financial resources or the ability to obtain them;

Should the taxpayer seek tax court review, this will not be a final tax liability until the taxpayer has exercised all judicial appeal rights.

(C) The taxpayer has entered into an installment agreement pursuant to I.R.C. §6159. The taxpayer is making timely payments and is in full compliance with the agreement terms. The taxpayer is not delinquent because the taxpayer is not currently required to make full payment.

(D) The taxpayer has filed for bankruptcy protection. The taxpayer is not delinquent because enforced collection action is stayed under 11 U.S.C. §362 (the Bankruptcy Code).

ATTACHMENT 1
PERFORMANCE REQUIREMENTS

Transportation service providers (drivers) proposed to be working under the contract must meet the minimum qualifications below:

- (a) English language skills - a good working level of English language for all drivers.
- (b) Local knowledge - Be completely familiar with local areas; at any given time, know alternate routes should primary route be impassable or otherwise not the best alternative.
- (c) Licenses – Possess a valid driver’s license of the following categories: B, C, D.
- (d) Good communication skills.
- (c) Computer skills: working level.
- (d) Ability to obtain a driver’s medical certificate.
